This also applies in case that only a subsidiary undertaking triggers a threshold and thus discloses a notification (if its parent undertaking has not triggered a threshold at the same time it is not subject to the notification obligation). In case of multiple chains the chains have to be presented chain by chain leaving a row free between the different chains (e.g.: A, B, C, free row, A, B, D, free row etc.).

Whereas the names of the different companies have to be provided in any case, the percentages of their holdings have only to be provided if these reach or exceed the lowest applicable threshold (3% or 5%). However, this rule does not apply in cases where voting rights are attributed only due to the fact of being a parent undertaking (Sec. 22 and Sec. 25 WpHG), i.e. in these cases the percentages of their holdings shall not be provided. The attribution of voting rights in these cases is already made transparent by providing the order of chain of controlled undertakings.

<sup>xvii</sup> (Non-binding) Examples could be found in the annex to the FAQ-list of BaFin (currently only available in German) as well as on BaFin's homepage (available in an English version). The qualified organizational chart may contain only the relevant information of a group notification, i.e. chain and names of controlled undertakings as well as details of the holdings according to footnote xv.

<sup>xviii</sup> Relevant holding is the (cumulated) holding according to Sec. 9 and Sec. 10 WpHG after the general meeting, as Sec. 22 para. 3 WpHG refers only to the notification obligation under Sec. 21 WpHG.
