

Aumann grows revenues by 25% and order intake by 51% in first quarter 2018

Aumann AG („Aumann“, ISIN: DE000A2DAM03) grew by 25.3 % in the first quarter 2018 compared to the first quarter of the previous year and reached revenues of €63.2 million. Revenues in the E-mobility segment reached €19.7 million, corresponding to a growth of 39.1% compared to the previous year.

Order intake increased by 50.9 % to €72.4 million of which 43.5 % were in the E-mobility segment. Taking into account the large number of new orders in the fourth quarter 2017, Aumann is very content with the continuing high order dynamic. At the end of March 2018, total order backlog reached €213.3 million, which was 64.5% higher than in the previous year. E-mobility accounted for 38.7 % of the order backlog.

Adjusted EBIT in the first three months reached €7.5 million, corresponding to an EBIT margin of 11.9 %. Profitability was especially positive in the E-mobility segment, where the EBIT-margin reached 14.2 %. The increase in profitability reflects the company's progress in eliminating capacity bottlenecks which occurred in the second half of 2017.

In order to meet the strong market demand, Aumann plans to further expand its capacities organically and through acquisitions. With €102.6 million in cash and an equity ratio of 52.8%, the company has plenty resources for these investments. In 2018, Aumann expects to grow revenues to more than €300 million and adjusted EBIT to between €28 and €31 million.
